Options – Changing Delegation

- Align \$\$ thresholds with large peer transit agencies
- Higher \$\$ threshold for "Construction" vs. "Services"
- Unified \$\$ threshold for "Services" and "Personal Services"
- Perhaps maintain lower \$\$ for non-competitive contracts

Options – Using Consent Agenda

- Instead of changing delegation, use the consent agenda for contracts the board sees as "lower risk"
- Potential concept:
